We are pleased to present you with the Annual Education Report (AER), which provides key information on the 2022-23 and 2023-24 educational progress for the Mount Clemens Community School District and our schools. The AER addresses the complex reporting information required by federal and some requirements of state laws. Our staff are available to help you understand this information. These reports contain the following information:

Student Assessment Data –

- Includes the following three assessments: M-STEP (Michigan Student Test of Educational Progress), MI-Access (Alternate Assessment), and College Board SAT/PSAT
- Presents assessment information for English language arts and mathematics for grades 3 to 8 and 11, and M-Step social studies and science for grades 5, 8, and 11, compared to state averages for all students and subgroups of students.

Accountability – Detail Data and Status

The accountability portion of the AER includes assessment proficiency and participation rates, graduation or attendance rates, as well as accountability index values showing school performance on a 0-100 scale.

Teacher Qualification Data

- Identifies the number and percentage of inexperienced teachers, principals, and other school leaders
- Reports teachers who are teaching with emergency or provisional credentials
- Includes teachers who are not teaching in the subject or field for which they are certified

NAEP Data (National Assessment of Educational Progress)

- Provides state results of the national assessment in mathematics and reading every other year in grades 4 and 8

Civil Rights Data

- Provides information on school quality, climate, and safety

Review the table below listing our schools. For the 2023-24 school year, schools were identified using definitions and labels as required in the Every Student Succeeds Act (ESSA). A Targeted Support and Improvement (TSI) school has at least one underperforming student subgroup.
