- Develops lesson plans, instructional materials, and appropriate tasks and provides differentiated and small-group instruction to adapt the curriculum to the individual needs of all students.
- Use qualitative and quantitative data to inform decision-making and instructional strategies.
- Share best practices and support differentiated instructional opportunities and strategies.
- Maintain required student records
- Attend all required professional development workshops and staff meetings.
- Fulfill all contractual obligations as a professional staff member in the bargaining unit. We respect our end of the contractual obligations and expect you to do so.
- Utilizes repertoire of all types of curricular materials, as appropriate.
- Establishes learning objectives consistent with appraisal of student needs, curriculum framework, and state standards.
- Conducts ongoing assessments of student learning and progress, modifies instructional methods to fit individual student's needs, and provides individual and small group instruction as needed.
- Participate as an active, effective member of a professional learning community.
- Perform other non-instructional duties, including curriculum, instructional, and assessment development activities; student supervision; and consultation activities as required by school and/or district administration.

- Certificate of Clinical Competency in Speech and Language Services or valid Michigan Teaching Certificate as a Speech and Language Impaired teacher approved by the MDE.
- Must attain a Speech-Language Pathologist License through the State of Michigan Department of Licensing and Regulatory Affairs or temporary licensure.

Position Description:

- Develops, implements, and coordinates the school district's speech and language program and goals, including vision, procedures, and goals.
- Evaluates students' speech and language needs using appropriate tests, professional observations, and supplementary information from other sources.
- Coordinates speech and language services with support and instruction provided by other school personnel, including teachers, administrators, and other student support personnel.
- Interprets assessment findings and conveys information to parents and school staff.
- Conducts speech, language, and hearing screens and obtains additional diagnostic information from appropriate personnel and available records for speech and language purposes.
- Evaluates, monitors, and reports on student progress in formal (IEP) and informal meetings with families and school staff.
- Plans evidence-based interventions appropriate for individual students and/or groups of students.
- Assesses the need for assistive technology and recommends its use at school to support the student's functioning as independently as possible.
- Complies with rules and regulations surrounding the Child Find process.
- Participate in MET/REED/IEP meetings.
